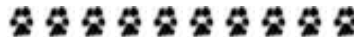

March 2012 Brags

Tiki finished her UD at Puyallup. She also finished her U-CD and got her first UDX leg. She is: HR,U-CD URO1, **ADIRONDAC'S KOURA TIKI**, UD, BN, GN,GO, VER, TDX, AX, OAJ,NF, RE, SH, WCX,CCA, Can CD, TDX, WC

At a "mock" Nose Work trial, she successfully completed all four elements – box work, car search, exterior search and interior search, which was done by about 25 percent of the 39 dogs entered. She finished first in Sporting Dogs, first in box work, and third overall. Placement is done by score and time. It doesn't count for anything but bragging rights, but I learned a lot. Given the 15-hour investment in time for the day, \$60 entry fee for each dog (I ran Koki too who did okay, but only passed three elements), ferry fare and gas, I was questioning my sanity. I enjoyed running my girls, watching some of the dogs run, but it was an awful lot of sitting around time.
