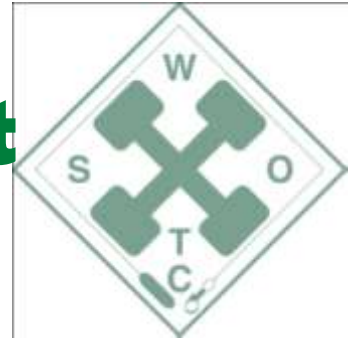

Failure Leads to Learning

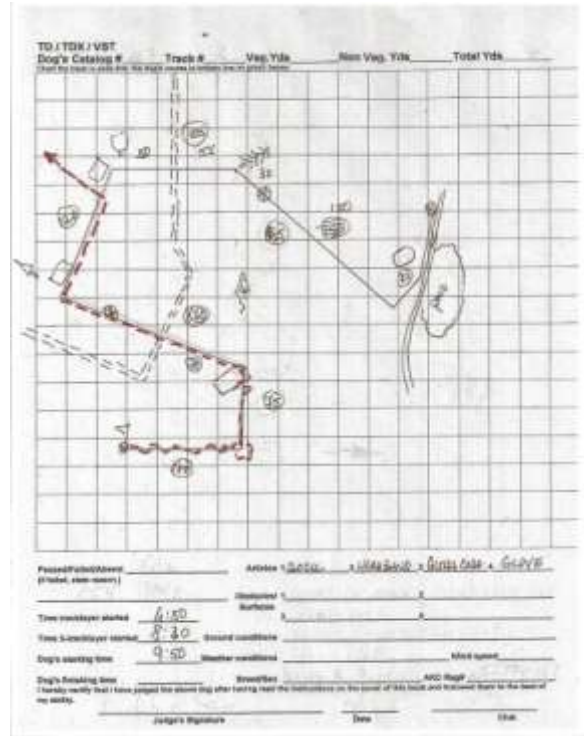
Well, we didn't pass our TDX test at Fort Lewis on Sunday, April 22, but we didn't exactly fail either.

We arrived at the Little Park Restaurant early enough to have breakfast and I waited for the draw well-rested, fed and relaxed. We drew the ideal number—track 2 of 6—not the first one of the day so that you'd feel rushed, but you don't have to hang around and wait through the heat of the day either. And, after the rain earlier in the week, Sunday was hot. We ran at about 10:00 a.m. and it was already over 70 degrees in brilliant sunshine. By the time the last dog finished at 2 p.m. it was past 80 degrees.

Sil Sander's official judge's map shows the total track length was about 805 yards. Maddie did outstandingly for the first 460 yards or so, correctly indicating the start article (a sock) and the second article (a headband). And she had no trouble ignoring the first human cross-track and staying on the designated track, and she solved the first three corners. I was watching her head, shoulders and tail intently and I had utterly no clue where we were.

The rectangular patches shown on the map provided an interesting change of cover during the track. They're about 20' x 40' of scrubby dirt and strung with wires on the ground between rows of what look like yellow squib covers. In cooler retrospect I suppose they are prepared areas for landing zone lights. But at the time all I could think of was that they might be practice mine detection areas and I think I ought to get extra credit for trusting Maddie to lead me through safely. The second corner was actually in one of those patches. (Yes, the thought did actually cross my mind...the tracklayer must have crossed here safely, and if Maddie is following her exactly...let's all tiptoe quickly...)

Instead of trotting full out as she sometimes does, Maddie worked at a steady but slightly slower pace. I think it was really hard to detect that three hour old scent and she had to work very deliberately. As you can see from the map, she did weave a bit at the first leg. Part of that was settling down and part was because the tracklayer apparently walked over the Scotch broom clumps and Maddie zigzagged around them.

So, things were going well. And then for some reason—I don't know why—Maddie stopped just before what I later learned was the fourth corner. She indicated (to my eye) that she had run out of scent and started casting about but with only a step or two either side and only briefly. She turned left and with full commitment, even pulling right down in the harness, she headed off on her new course. I swung behind her and looked up and we were headed right for a road crossing. "Aha", I thought, "one of our required track obstacles!" Alas, whether she was following a rabbit or the Phantom of the Opera, it wasn't Joan our tracklayer and the whistle blew.

After brief condolences from judges Sil Sanders and Stephanie Gonyeau I let Maddie re-start from her known track and she carried me around the rest of the way with no further difficulties. We found the third article, a glasses case, and headed on, up and over a ridge—with Sil's cry of "Follow your dog, lady!" floating behind us—and around a tree and then...in the hollow...there was the pond. Did I mention it was hot for my little girl with the heavy black coat? Although the track didn't go through the pond, Maddie did. When I got her to get out of the water she happily went back to the track, recommitted to it, trotted down it and pounced on the glove, to wild praise and pets.

While of course I'm disappointed not to have passed the TDX, the good things I'm taking away from this are: Maddie really CAN track a three hour old track laid by someone else, and about which I have no clue, despite unfamiliar terrain and obstacles. And Maddie knows what her job is—and enjoys it. We just have to work on proofing and steadying her focus.

As for Maddie, she had a blast (well, she did miss finding the hot dogs on the track, and the jackpots under the articles, but it was made up to her as soon as we got back to the car, believe me). She loves road trips, sleeping on motel beds and sharing take-out Italian dinners. She had a great time running about in the wild outdoors of the Lewis ranges, and being the full-time center of her Mommy's attention. In fact, she had so much fun she's ready to go do it again. So I submitted our entry to the Spokane Dog Training Club's TDX test in Sprague and we're the first alternate.

My thanks to everyone who made this test happen—and it surely takes the efforts of a whole host of committed and generous people. We had a wonderful day, reconnecting with so many good friends (and their dogs) we have made at tracking trials and seminars over the years, and meeting new ones. Barbara Reed-Stamps, once again, handled all the paperwork involved with being a test superintendent. And Jackie Lovette was both tireless and organized, getting tracklayers where they ought to be, when they needed to be. And to all the tracklayers: thank you! I've seen you all at so many tests—you made this event possible! And I promise that once Maddie passes her TDX, I'll pay my debt to the sport and join you! We'll see you in the field. Best to all, both two- and four-footed. 🐾

Opportunities to Serve

The WSOTC Agility Trials at Argus Ranch on July 13, 14 and 15 are held outside on grass but can be moved inside if the weather refuses to cooperate. 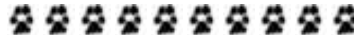
I entered Koki and Tiki in Nose Work 1 at the trials in Fife, WA, on April 14 - 15. On Saturday, when Koki was entered, there were 22 passes out of 32, of which she was one. She did well and would have been 7th overall except that we had a "fault", because I dropped a piece of food. You are allowed to reward after each find, but you get faulted if you stupidly drop a piece of food as you are rewarding. Lesson learned. I was extremely careful after that! The overall is for all four "elements" to the test: container search, interior search, vehicle search and exterior search. They also have placements for lowest time for each element. She is now: UH,HRCH, U-UD,URO1, Can OTCH AERO-JETTS KOKOPELLI DREAM UDX, TDX, MH, WCX, AX, AXJ, NF,OAP, OJP, RE, TN-O, TG-O, OJC, OAC, NAC,NCC,WV-N, NW1, Can SH,TDX, WCX

Tiki was entered on Sunday and not only got her title, but she also went "High in Trial" meaning she had the lowest overall time for all the elements. That was pretty exciting. There were only 11 of 32 dogs that passed all four elements that day, and she also had the lowest time for the exterior search. For the interior and exterior searches we were given a "pronounced" designation, which is supposed to be an acknowledgement of exceptional teamwork, speed, efficiency, accuracy, enthusiasm, clarity of alert, etc. She is now: HR, URO1, U-CD ADIRONDAC'S KOURA TIKI, UD, BN, GN,GO, VER, TDX, AX, OAJ, NF, RE, SH, WCX, VCX, CCA, NAC, NWI Can CD, TDX, WC
