

## Disaster Preparedness for Pet Owners – Free Workshop

Join Family Dog Training Center's Lee Cummings for an informative talk on Disaster Preparedness for Pet Owners on Saturday, February 23, from 10 a.m. to noon at Family Dog in Kent, WA. Lee will provide handouts and demonstrations so you can prepare for disasters that may impact your family (and pets). Learn what to do and where to go in the event of earthquake, fire, flood and more. Lee will show you how to make a disaster kit for your animals (in the event you need to leave your home) and discuss ways to make your home safer, and better prepared, in the event of a disaster. In addition, Lee will help you learn where to go if you need to evacuate with your pet, and talk about facilities that will care for pets if your animals cannot evacuate with you.

Lee is Trainer for Community Emergency Response Teams (CERT) and FEMA Disaster Training, a City of Renton Emergency Response Volunteer, member of Evergreen Golden Retriever Rescue and Senior Instructor for Family Dog Training Center. In her spare time she also trains and shows her own Golden Retrievers.

This is a free workshop for humans, so please leave pets at home. ## Volunteering for 4-H Equals Win-Win

The Snohomish County 4-H program needs volunteers for club sponsored dog events such as judging contests and participating in fairs. You do not need to be an AKC judge in order to judge 4-H obedience.

We also need dog and handler teams of all levels to demonstrate obedience exercises in a mock competition setting. This is a great opportunity to work your dog in a new scene.

For example, volunteers participate in a mock Novice trial. A 4-H leader will call the exercises like a judge. The audience includes 4-H kids busily taking notes on clipboards. By doing this they learn what to look for and how to express those observations in writing and later orally.

This is a great opportunity for someone who has never been in an obedience trial to get the butterflies out. It is also a great opportunity for your dog to work in a new location. Think of it as a free and quick fun match!

Since the kids are just learning, it is great to have absolute beginners as well as advanced handlers to compare. Trust me, we've had dogs just sit in one location while the handler walked the heeling pattern solo! The idea is that the 4-H kids are learning to catch and make note of mistakes, so it's a good place for handlers to make mistakes. It's also good to have an experience handler (ringer) to contrast, so anyone is welcome!

The 4-H leaders are needed to teach the skills, so we are hoping to get members of the community to help us with the "dog skills". Hopefully it will be a win-win situation.
