PREZ'S MESSAGE

The summer is flying by. Not an unusual occurrence. What is unusual is that it is flying by without our local dog shows, agility trials and hunt tests. If you are attending and competing in dog events, you have hit the road and found states that are not in the same COVID-19 lockdown situation that we find ourselves in here in Washington State.

I hear occasionally from friends who are showing in these other states. The virus has left its mark on our sport and left us with a bunch of questions to be answered. For example:

> Does a site have enough indoor space to crate dogs and keep owners at a safe social distance? How should armbands be distributed? Should the premium state that all handlers must wear masks? Can this be enforced?

While in the ring can you lower your mask for recalls? Is this a double command? Should this be at the judges discretion? If it's allowed in one ring but not in another will it affect HIT? Can my dog hear me if I am wearing a mask? Should the dumbbell be placed on a chair and the handler go get it? If the judge handles it, do they sanitize before picking it up and/or after?

These are just a few of the issues that have come up recently. Hopefully by the time we are back in 'show business' here, most of these types of questions will have a definitive answer. One lesson I have learned is that working my dog in a mask is hot business, my glasses steam up and I need to practice to get comfortable with the process.

AKC has left those of us without a show in the near future with a virtual option. Trick dog titles as well as some Rally and Agility titles may be earned virtually. These titles do require some equipment as well as more than a little bit of filming talent. If you have earned titles through the virtual option I hope you will share your accomplishments with the rest of the club. I would love to see a write up of the process in the newsletter.

Meanwhile, enjoy the rest of the summer with your dogs. Stay safe!


