# REQUEST FROM 4-H

Hi Nancy,

The reason I am emailing you, is to inquire whether or not you or if you know of other members of WSOTC are interested in Judging for the King County Dog 4-H program? I am and have been for the past 3 years, the Superintendent for the King County dog project and one of my tasks is to find us judges! Our obedience judge list pool has dwindled the last few years but I would love to get a better network of judges who enjoy working with kids for future events! (I know working with kids is not everyone's cup of tea!) Most of our events and matches are at Argus or the Enumclaw Expo Center. Are you interested or know of anyone who might be interested to be put on our judges list? We compensate our Match judges \$50 for their time plus travel compensation and meals and our Fair Judges \$100 (longer days than our matches) for their time plus a travel compensation and meals! When I was a member Shari Wright one of the past WSOTC members was our obedience trainers for our club and we met at the Lake City Community center where there were WSOTC training classes that met after our 4-H meetings which made me think to contact you and WSOTC!

4-H does have its own set of obedience classes, most which follows the AKC classes (Beginner Novice, Novice, Open, Utility...) but we also have a few that deviate as "stepping stone classes" (sub-novice-similar to novice but all on leash, Pre-Novice-mix between sub-novice and novice, Advanced Novice-modified drop on recall, long sits/downs...) We are happy to train people on the specific classes! Since working with kids in this fashion is not everyone's strength, since it requires some additional flexibility working with kids and our fair we are battling elements that you normally do not have to face at a normal show (last year the fairgrounds put the Pirates next to us and their main attraction was shooting off cannons and pistols... needless to say we had to do a few unplanned intermissions when the shows occurred).

Please let me know if you are interested (and if there are different levels of classes or ages you prefer to work with) or if there is anyone else that you could share their email or phone number with me so I could contact them to see if they are interested! Or if you have any additional questions, please don't hesitate to ask!
