#### Entries Limited to 3 TDU - CLOSING DATE 11/21/24 AT 4:00 PM PST.

**ENTRY FEES: TDU - \$75.00** (includes \$.50 AKC recording fee and \$3.00 AKC Event Service Fee) Fees must accompany all entries.

- Express mail entries must include signature waiver.
- No Fax, Email or any other electronic entries will be accepted.
- A \$30 fee will be charged for any returned check
- Returned checks do not constitute a valid entry
- Fees must accompany all entries.

#### **GENERAL INFORMATION**

Entries will be limited to 3 TDU entries. Entries will be accepted until the official closing date, even though the advertised limit has been reached. If entry limits are exceeded, <u>a drawing will</u> <u>be held on THURSDAY</u>, <u>November 21</u>, <u>2024</u>, <u>at 6:30 PM</u>, <u>at the Secretary's home</u>, <u>to determine which entries will participate</u>.

TEST WORKER OPTION: At the Draw for Participants, 1 Track will be set aside as per Chapter 1, Sec. 17d. Please put "Test Worker" at the top of your entry and include your Worker Certificate. The drawing shall be completely random. However, preference for entry in the TDU will be for dogs that have not yet earned an AKC tracking title. When the advertised limit has been drawn, all remaining entries, subject to the same preferences set forth in the preceding paragraph, shall be assigned a position on an alternate list corresponding to the order in which they are drawn. Alternates, based on the Catalog order, who are present at the test site at the time of the Track drawing, will be used to replace absent dogs.

Alternates not used will receive full refund of entry fees shortly after the test. WSOTC will also refund the entry fees to any confirmed entrant who does not participate in the test provided that the Test Secretary is notified prior to the Day of the Test and provided an alternate entry participates in the test as a result of the withdrawal.

**ACKNOWLEDGEMENTS** will be by phone, mailed or emailed by the Test Secretary after the closing of entries if the address is included in the entry. The Secretary will respond to email requests to confirm that entries are received. Please allow 48 hours as per Chapter 1, Sec. 17. # Please make sure all information is readable on your entry form! AKC Titles ONLY.

<u>We ask that TDU exhibitors do not arrive prior to 7:45. Please park where instructed.</u> If you arrive early there is a Town and Country grocery store at 155<sup>th</sup> and Aurora that has restrooms.

#### TDU TEST:

All TDU entries must either have a TD title, TDU title or send an AKC Tracking Certification with their entry, See Chapter 7, Sec. 2. **Confirmed entries for the TDU test must be at the Test HQ by 8:00 AM, Sunday, December 1, 2024, at which time there will be a drawing for tracks** for each dog entered. In the event of any absentees among the confirmed entries, the next alternate in catalog order who is present will be allowed to fill the vacancy.

BITCHES IN SEASON may participate subject to the provision set forth in Chapter 2, Section 8

of the AKC Tracking Regulations, effective February 1, 1998. The Test Secretary must be notified that a bitch is in season prior to the drawing for tracks. The dog will be given the last track and will not be allowed in the tracking area until just prior to running her track. In the case of more than one bitch in season at the test, a second draw for the last tracks will be held immediately after the first draw.

**REFRESHMENTS** will NOT be provided.

**PRIZES:** An award will be given to all dogs passing this test.

By their presence at the Sites, all exhibitors and spectators agree to abide by AKC Rules and Regulations and to follow the instructions of the Tracking Test Committee and Judges. While all care will be taken to insure the safety of both people and dogs, the Washington State Obedience Training Club, the Tracking Test Committee, the landowners, their employees and their agents assume no responsibility for any loss, damage, or injury to ay dog, person, or property on the Sites, or loss, damage or injury to and do, person or property traveling to or from the Sites.

ALL DOGS WILL BE KEPT ON LEASH AT ALL TIMES IN ANY AREA OF THE TRACKING SITES. Owners are responsible for picking up after their dogs and keeping the Sites clean.

#### **DIRECTIONS TO THE SITE:**

From North: I-5 South take Exit 176 east turning left onto NE 175<sup>th</sup> St. Turn right onto 5th Ave NE to NE 155th, Turn left to the east on NE 155th to 8th Ave NE and then right to the south on 8th to the Park entrance on the left

South: I-5 North to Exit 175 onto NE 145<sup>th</sup> St, SR-523. Turn right onto NE 145<sup>th</sup> St. Turn left onto Eighth Ave NE. Paramount Park is on the right in .4 miles.
